The DAX[®] is Deutsche Börse's blue-chip index for the German stock market, one of Europe's most efficient stock markets. It's comprised of the largest and most actively traded German companies*.

Futures and options on the Mini-MDAX[®] and TecDAX[®] are convenient way to gain exposure to Germany's innovative, international recognized manufacturing and technology base. DivDAX[®] selects the companies with the highest dividend yield from the DAX[®].

Due to global investors' increased demand for smaller sized futures, Eurex introduced Mini-DAX[®] Futures and Micro-DAX[®] Futures and Options with contract sizes that are 5 to 25 times smaller than the regular DAX[®] derivative contracts.

The smaller sized contracts give investors across the globe the opportunity to fine-tune their German benchmark index exposure with significantly lower contract values.

* In September 2021, the benchmark index DAX[®] expanded by ten members, to a total of 40 constituents and MDAX[®] Index was reduced from 60 to 50 constituents.
