The company Atos SE has announced a rights issue whereby shareholders are entitled to purchase 13497 new share(s) for every 24 share(s) held, at a subscription price of EUR 0.0037 per new share.

More information about this transaction is available on the company`s website.

The rights issue will result in an adjustment of the above-mentioned contracts.

Procedure

Considering the configuration of the Rights Issue, the adjustment methodology will be carried out in two steps.

Step 1:

Effective 12 November 2024 the following adjustment will be done:

Basket Method

- As of the effective date, the current underlying will be replaced by a Basket consisting of 1 Atos share plus one Atos subscription right
- Strike Prices and contract size remain unchanged
- The basket underlying price will be calculated as follows:

(1.00 x price/closing price of Atos SE share at Euronext Paris) plus (1.00 x price/closing price of the Atos subscription right at Euronext Paris)

- Upon exercise of the Atos Basket option (100) Atos shares and 100 Atos subscription rights have to be delivered
- On 21 November 2024 no exercise instructions will be allowed
- As of effective date 20th November 2024, the underlying ISIN, the product ISIN and the product code of the Atos options contracts will change in Eurex Exchange`s T7 as follows:

Step 2:

Effective 22 November 2024 the following adjustment will be done:

Basket Method

- The current Basket underlying consisting of 1 Atos share plus 1 subscription right will be replaced by a basket consisting of one Atos share plus one Cash component. The Cash component is the value of 1 Atos subscription right converted into cash based on the closing price of the Atos subscription right on 21 November 2024 (last trading day of the subscription rights)
- The basket underlying price will be calculated as follows:

(1.00 x price/closing price of Atos SE share at Euronext Paris) plus (Cash component)

- No adjustment will be made to strike prices and contract size
- Upon exercise of the Atos Basket-Option (100) Atos shares and (100) cash components have to be delivered
- No further series and maturities will be introduced
- As soon as there are no series with open interest available, trading will be terminated with immediate effect.

Futures

- Trading in the respective futures contracts has been discontinued.
